

CDE Committee Meeting BOD Report
July 2022

I. Fixes that need to be made. Remind

- A. Fall LDE written material will be online and submitted by the date assigned by the state. The ONLY exception to this rule is Ag Issues. Ag Issue state qualifiers MUST turn in 4 hard copies to registration (by 5:30 pm) and the judges will then judge the completed portfolio at that time.
 - 1. Originality form/participation form is part of the pdf submission as one single pdf.
 - 2. Employment skills will be a one single pdf submission that includes application, resume and cover letter in common word processing format.
- B. Liaisons - If you do not want to be a Liaison or assistant Liaison PLEASE tell Kelly Dunkelberger ASAP. If you are a Liaison please make sure you do the job that is asked and if you are not sure what is asked/required please talk with Kelly Dunkelberger BEFORE the LDE/CDE happens.
- C. Parli Pro Sr. Rules - Just needs to be updated from we need to fix them so that it says in there that they cannot use main motion as 2nd ability. This was voted on and passed in 2021 just needs to be updated in rules.

II. General Rules for Both Spring and Fall

- A. Phones - The chairs of all LDE/CDE will be informed that the SD FFA Associations' position on Cell Phones is that we will NOT take cell phones at the beginning of any event as a whole. At the beginning of the event please make a note to announce that ALL cell phones must be turned off at this time and if you are caught with your cell phone out of your pocket before you leave the event you will be DQ'd. The ONLY exception to this rule will be for medical use. The advisor must let the CDE Committee Chair/State Staff know that this might be needed. The student will be required to inform the chairs/workers of their medical needs to possibly have their phones out for medical reasons.
- B. Scantrons will continue to be handed out at the CDE event. The chairs will be told that all participants will have 5-10 minutes to work as a chapter to complete their Name, School ID, and Team Number portion as a school. Each school is encouraged to work with your team and even select a team captain to check all scantrons to make sure they are completed correctly. A list of chapter ID numbers will be provided at each contest location.
 - 1. The CDE committee will continue checking and certifying results as is. We will not add additional time to double-check that school ids are correctly filled in.
- C. LDE/CDE Qualification Rules - These rules will not change. If you are on a state winning team or individual you are not allowed to participate in that LDE/CDE in future years, regardless of if you have competed in that event at the national level.
- D. NO videotaping of any LDE/CDE will be allowed at the state level.

III. Fall LDE's

- A. General LDE rules
 - 1. Viewing LEDs at the State Level.
 - a) Open to Advisor, Team members and chapter stakeholders DURING their chapters event

- (1) Ag Communication, Ag Issues, Ag Sales Team, Extemp, CCM, Parli Pro finals, Marketing Plan, Prepared Public Speaking
 - b) Open to Chapter Advisors and chapter stakeholders ONLY for their members only
 - (1) Parli Pro Preliminary Round, Ag Broadcasting, Creed, Employment Skills
 - c) Chapter Stakeholder is determined by the chapter advisor. This must be told to the door monitor and the chapter advisor is responsible to make sure they let the door monitor know and make sure that stakeholders and members are quiet and respectful during the event.
 - d) Advisors/members/chapter stakeholders are NOT permitted to watch any other teams/individuals throughout the event.
- B. Ag Communication Scenarios - Leave in Fall - scenario should be sent to state staff from the national office soon!
- C. Prepared Public Speaking
- 1. Tie Breaker #2 will be - Total Overall Questions
 - 2. The Prepared Public Speaking rubric will be updated to follow the National rubric for judging. This will be approved by the CDE committee, Liaisons and state office.
- D. Ag Issues - We will give the event more time so that the judges are allowed adequate time to write comments to the teams. Extra time will not be given for the judges to give feedback in person.
- E. Extemp
- 1. Rules will be updated to read that the timer will show a warning at 4 min., 5 min., 6 min.
 - 2. Tie Breaker #2 will be - Total Overall Questions
- F. Creed
- 1. The question section will be worded to encourage the members to learn the intent of the question and the judges will ask questions from the list but can change them using the same intent.
- G. Ag broadcasting
- 1. Tie Breaker #2 will be - Overall Delivery Score
- H. Employability Skills
- 1. Tie Breaker #2 will be - Overall Personal Interview Score
- I. Ag sales Indv sale
- 1. Business cards will be allowed but there will be no points for this and note that it is NOT allowed at the national level. NO other material will be allowed to be handed to the judges.
 - 2. Any other materials (ex. Pamphlets, flyers, hats etc..) that are not printed right from the state website will result in a disqualification
 - 3. Top Salesperson from each of the 4 individual rooms will be chosen based on the individual scores. This will be a sponsored by award and sponsors have already come forward. Details are being worked out if funds go through Foundation or state office.

- J. Creed LDE will stay the same as is.
 - K. CCM discussions and amendments were brought forward. An amendment to the final motion was made to say they can compete until they win state and that failed by a 39/24. The final decision will be updated on the state rules to read:
 - 1. Update the rules to state "Students may only compete once at the state level. A student/team may compete numerous times at the district level 7th, 8th, and 9th grade. Once a student has been on a team that has qualified through their district competition for state they are no longer eligible to compete in the CCM LDE." This motion passed with a 42/11 in favor of the motion.
- IV. SPRING CDE's
- A. Dairy Cattle - Add one more class of oral reasons to make it 2 oral reason classes
 - B. Meats, Livestock, Dairy, Horse - Notes may be taken for the questions classes but notes may NOT be used when questions are being asked. Add this information to the rules of each CDE.
 - C. Meats
 - 1. Country Style Ribs will be moved to various Meats (not Loin anymore)
 - 2. Judging Classes - Retail Cuts will be added
 - 3. The resources section of rules will be updated to add The Meat We Eat and the other resource will be taken out.
 - D. Floriculture - Conversions for problem-solving - CDE Committee will talk with the Chairs to see if a sheet can be created to add to the rules.
 - E. Food Science - Rules will stay as 4 participate/4 counts.
 - F. Range Plant ID - The plant list will be updated from the 2019 to 2022 list that was revised in the summer of 2022 by the NRCS office.

These are the recommendations that will be passed on to the BOD at their September meeting from the CDE Committee on behalf of the AFNR educators.
